COVID-19 SHIFTED THE FOCUS AND PROCESS, AND 36 IN-DEPTH BUSINESS INTERVIEWS WERE CONDUCTED WITH QUESTIONS REGARDING RESILIENCE DURING THE PANDEMIC. A STRONG LOCAL TASK FORCE MEETS WEEKLY, WHICH HAS
